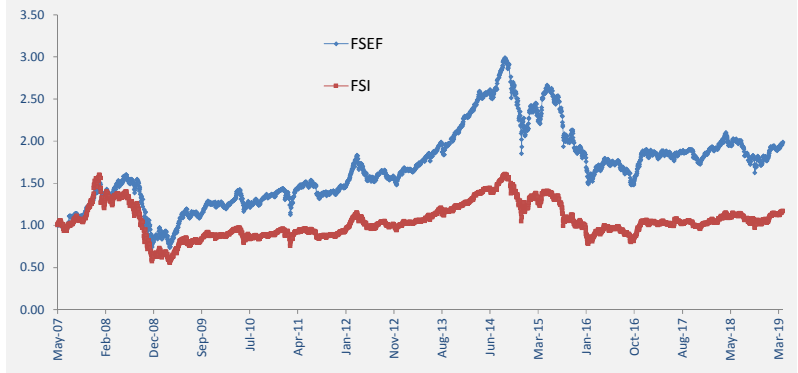

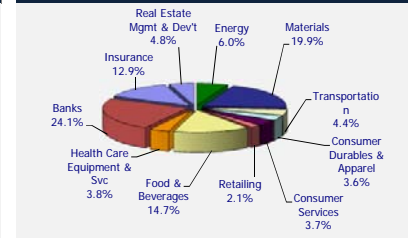
Performance Fund vs Benchmark
